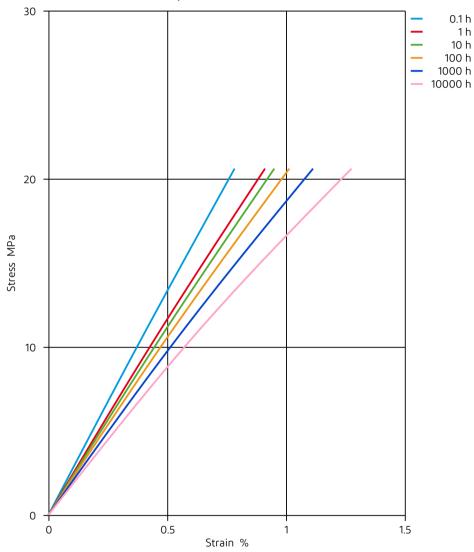

Stress-strain (isochronous) 23°C (measured on Crastin® S600F40 NC010)

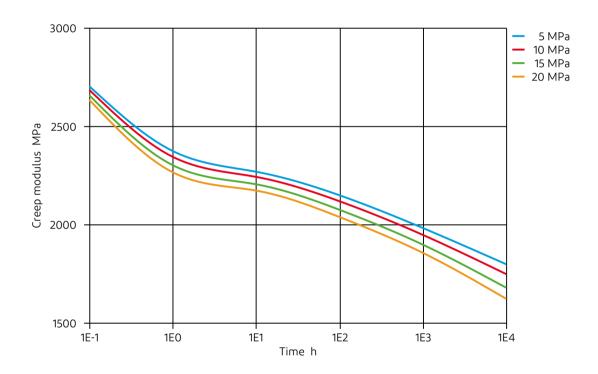
